#### (a) <u>2017-736</u> BRIEFING BY CITY STAFF

Chairman Michael Schultz called on Mr. Jeff Thompson, Deputy Manager. City Mr. Thompson stated there is a need for diversity of housing. The proposed restricted project from 210 Development Group is an age project. Staff housing is in support of this project.

## (b) <u>2017-737</u> JOEL POLLACK WITH 210 DEVELOPMENT GROUP WILL MAKE A PRESENTATION REGARDING THE PROJECT

Chairman Schultz called on Dave Richardson of 210 Development Group. Mr.

Joel Pollack was unable to attend the meeting due to unforseen circumstances. Mr. Richardson stated this apartment complex will be high quality for seniors ages 62 and above. At least 50% of the units will be for seniors whose incomes below 60% of the area median income. The remainder are at or will be at market rate. 210 Development Group plans to apply for a waiver to increase to 70 % of units. There will be a full service kitchen, activities director, and library. A site plan was displayed. Discussion ensued about the number of stories for the apartment complex, whether an elevator will be available, and the rental rates.

## (c) <u>2017-738</u> JIM PLUMMER WITH NORTON ROSE FULBRIGHT US LLP WILL DISCUSS THE LEGAL STRUCTURE AND CORPORATION'S ROLE

Schultz called on Mr. Jim Plummer, Attorney for the Public Chairman Boerne Facility Corporation (PFC). Mr. Plummer stated the proposed development will seniors only. The PFC will enter into partnership or а development lease of with agreement, agreement, and the project the Plummer explained the PFC would issue bonds to development entity. Mr. help finance the project and would create a single member limited liability company to serve as the general partner of the tax credit partnership. The PFC will own the land lease it to the tax credit partnership for 75 years. Discussion and ensued about how the money is funneled back to the city and the amount of time it takes and any use restrictions. A concern regarding the cost of rent for this type of housing vs. regular apartments arose.
