Mayor Schultz called the City Council to order at 5:45 p.m.

Mayor Schultz called on Mr. Paul Barwick, Special Projects Director. **Barwick** Mr. discussed the RUDAT conducted 2008, which recommended welcome in a visitors center downtown Boerne. center or in Discussion ensued about different locations the City has looked at over the years for a Convention and Visitors Bureau (CVB). There has been talk about a new CVB location in the downtown area for five to seven years. Mr. Barwick reviewed the benefits of having a **CVB** downtown, the various City Council meetings regarding CVB, and the possibility of the CVB being located in the new City Hall building once constructed. There is а possibility of using grant funds for permanent the amount of \$160,000.00. landscaping improvements in Statement of Qualifications were requested with four firms submitting proposals. Staff recommends negotiate for architectural approval to an agreement and engineering services with Peter Lewis Architects & Associates.

A total of 367 votes were cast for Council Member District 1. There were 27 voters who cast a ballot but, did not vote for either City Council candidate. The oaths of office will be administered at the May 24th City Council Meeting.
