#### 2. 2018-617 DISCUSSION AND PRESENTATION BY TEXAS DEPARTMENT OF (TxDOT) KENDALL TRANSPORTATION OF THE GATEWAY STUDY. (No action to be taken)

Mayor Schultz called Laura Talley, Planning Community on Ms. and Ms. Talley introduced representatives from TxDOT Development Director. and BGE, Inc. who conducted the Kendall Gateway Study. Jonathan Bean, TxDOT's Planning and Development Director spoke on the unified goal of moving people today and in future. He stated the Kendall Gateway Study began in 2015. He of the growth in Kendall County since displayed а map 2005, noting that Kendall County is the 5th fastest growing county in the nation. The data TxDOT received for the Study was data driven using technical analysis and public involvement and feedback. The goal of the study is to identify viable corridors with intent to preserve right of way. He spoke on the need for a 300 ft corridor. It gives the ability to plan, to include drainage, expansion and overpasses. He compared the project to Loop 337 in New Braunfels. Mr. Bean stated that at this time there is no funding. This is only a study that determines the next steps. Discussion ensued regarding the alignment, environmental study, and hazardous cargo routes. Discussion continued with how the study will affect property values, what is equitable to landowners, and the harm in pausing the project.

#### 4. PUBLIC COMMENTS:

Denise Dever, 53 Silent Springs spoke on the Kendall Gateway Study. She stated that in addition to the Workshop, the Kendall County Commissioners will also hold a Public Hearing on October 4, 2018 at Kronkosky Place at 2:30 p.m. and 4:00 p.m. She discussed hazardous cargo on the highways.

Jonah Evans, 117 Oak Lane spoke on the Kendall Gateway Study. He felt there is harm in moving too quickly on the project and that the proposed loop will cause a large influx of traffic using Hwy 46 rather than IH-10. He asked that Eminent Domain be used sparingly and to think carefully about taking peoples homes.

Benjamin Eldredge, 212 Azalea Trail spoke on the Kendall Gateway Study. He asked the City Council to take a cautious approach since the project impacts peoples lives and that eminiment domain should be used lightly.

126 Kendall spoke on Kendall Gateway Study. Tom Adelstein, Ridge the He discussed the impact on the community and that property values will be affected. He stated he attended the public meetings and thought it concerning that feedback given during the meetings but were not included in the study. He suggested that FM-3351 be used for the loop.

Mark Mason, 126 Spring Creek Road spoke on the Kendalll Gateway Study. He discussed his concern with the cost of the project and the lack of TxDOT

transparency. TxDOT should be meeting with landowners who will be impacted. He asked about other cities who have been through a project such as this. He questioned why TxDOT didn't start the traffic study from Hwy 281.
