Ms. Cohoon reviewed the qualifications as stated in the Home Rule Charter. lt. is the outside counsel and the City Attorney's office, that these establish residency at the new address which is outside District 1. Discussion ensued regarding calling for a Special Election to fill the vacancy. Ms. Cohoon stated that the Home Rule Charter 3.08 states that there cannot be appointed qualified persons on the City Council without having an election. fill one vacancy, the City Council will appoint a qualified person within 30 days of the vacancy who will serve the remainder of the term, until ensued regarding abiding by and interpreting Discussion also the Home Charter written in the 1990's and that the decision isn't about Council Member Anzollitto personally.

Mr. Mann continued with a photo of a Magna Drive pump assembly that was installed approximately 14 years ago at the Buckskin Water Tank Site, which is the GBRA water delivery point. This pump allows the City to alter the flow rates on discharge at the site. The Magna Drive is in need of a complete rebuild due to bearing failure. Because this equipment is vital, Staff recommended approval of the expenditure.
