1. CALL TO ORDER - 6:00 PM

Chairman Hollinshead called the P&Z meeting to order at 6:06 p.m.

2. Approval of Planning and Zoning Commission Minutes of the meeting held June 5, 2017.

5. 2017-474 Consider the approval for a preliminary plat for Regent Park Unit 3 (53 residential lots). Take necessary action.

Commissioner Pena made a motion to approve. Commissioner Chapman seconded the motion. The motion passed by a vote of 4-0.

COMMISSIONER PENA MADE A MOTION TO APPROVE. COMMISSIONER CHAPMAN SECONDED THE MOTION. THE MOTION PASSED BY A VOTE OF 4-0.

6. <u>2017-477</u>

Consider the approval of an on-site sewage facility for 115 Adler, as provided by the City of Boerne Subdivision Ordinance, Article 7, Section 06. On-Site Sewage Facilities, which allows an on-site sewer system rather than connection to the City of Boerne sanitary sewer system (Pizza Cave). Take necessary action.

Mrs. Talley explained a Pizza Cave restaurant is the proposed use for the site and the owner would like to use an on-site sewer facility instead of connecting to the city's sewer because the connection is too far, making it too costly for the property owner to extend the sewer main. The property also received approval by the county for the on-site sewer facility and the Public Works Director is supportive of the request.

COMMISSIONER COHOON MADE A MOTION TO APPROVE. COMMISSIONER PENA SECONDED THE MOTION. THE MOTION PASSED BY A VOTE OF 4-0.
